- Attractions : Travelers should expect to pay much more than locals for hotels, in-country airfare and entry into popular attractions. Tourism facilities in Yangon, Bagan, Ngapali Beach, Inlay Lake and Mandalay are adequate but limited in the rest of the country.
- Major points-of interest include : The Shwedagon Pagoda, glided with more than eight tons of gold: the Sule Pagoda: Twante- known for pottery and cotton-weaving and Bagan, know as the city of "over four million pagodas." Not known for its beauty, the historical old capital, Mandalay, remains the cultural center, with many historical sites, memorials and Buddhist edifices including the Golden Palace Monastery, Mandalay Hill and Kuthodaw Paya.








- 4) Free replacement would be made with new workers if any worker is found unqualified for the assigned work within 90 days after he/she assumes the job.
- 5) The company in contract should clearly mention the salary of a worker and other facilities mentioned under clause.
- Employer company should offer following facilities to the workers in written contract:
 - Salary
 - Accommodation
 - Food
 - Transportation
 - Medical Facilities
 - Insurance of worker
 - > 8 Hours per day
 - 6 days a week
 - Leace as per the labor law
 - Residence permit
 - Over Time (O.T) if worked more than 8 hours per day.

The contract letter should clearly be stated with the above facilities as per the rules and regulations of company.
